Subject: **REVISION OF BASIC PAY SCALES AND ALLOWANCES OF CIVIL SERVANTS OF THE PUNJAB GOVERNMENT**

I am directed to state that the Governor of the Punjab has been pleased to sanction Revision of Basic Pay Scales and Allowances **with effect from 1st July, 2026** for the Civil Servants of the Punjab Government as detailed in the succeeding paragraphs:

PART-I (PAY)

2. **Revision of Basic Pay Scales:**

The Basic Pay Scales – 2026 shall replace the Basic Pay Scales – 2022 with effect from 01.07.2026 as contained in the Annexure-I to this Notification.

3. **Fixation of Pay of the Existing Employees:**

- i) The basic pay of an employee who was in service on 30.06.2026 shall be fixed in the Basic Pay Scales – 2026 on point to point basis, i.e., at the stage corresponding to that occupied by him/her above the minimum of Basic Pay Scales – 2022.
- ii) In case of Personal Pay being drawn by an employee as part of his/her basic pay beyond the maximum of his/her pay scale on 30.06.2026, he/she shall continue to draw such pay in the Basic Pay Scales- 2026 at the revised rates.

4. **Annual Increment:**

Annual increment shall continue to be admissible, subject to the existing conditions, on 1st of December each year. However, the first annual increment of existing employees in Basic Pay Scales - 2026, in which their pay is fixed as on 01.07.2026, shall accrue on the 1st of December, 2026.

PART-II (ALLOWANCES)**5. Adhoc Allowances:**

The following Adhoc Relief Allowances granted w.e.f. 01.07.2022 & 01.07.2025, shall cease to exist with effect from 01.07.2026:

6. Adhoc Relief Allowance-2023:

- (i) Adhoc Relief Allowance 2023 is already frozen at the level of its admissibility as on 30.06.2023.
- (ii) All the new entrants shall be allowed Adhoc Relief Allowance-2023 @ 35% from BS-1 to BS-16 and 30% from BS-17 to BS-22 of minimum of relevant Basic Pay Scales, 2022 on notional basis with effect from 01.07.2026 till further orders and shall stand frozen at the same level.

7. Adhoc Relief Allowance-2024:

- (i) Adhoc Relief Allowance-2024 @ 25% from BS-1 to BS-16 and 20% from BS-17 to BS-22 basic pay of BPS-2022 shall stand frozen at the level of its admissibility as on 30.06.2026.
- (ii) All the new entrants shall be allowed Adhoc Relief Allowance-2024 @ 25% from BS-1 to BS-16 and 20% from BS-17 to BS-22 of minimum of relevant Basic Pay Scales, 2022 on notional basis with effect from 01.07.2026 till further orders and shall stand frozen at the same level.

8. Adhoc Relief Allowance-2026:

- (i) An Adhoc Relief Allowance-2026 @ 7% of the running basic pay of BPS-2026 shall be allowed to the Civil servants of the Punjab Government as well as contract employees employed against civil posts in Basic Pay Scales on standard terms and conditions of contract appointment till further orders;
- (ii) The Adhoc Relief Allowance-2026 will be subject to Income Tax;
- (iii) The Adhoc Relief Allowance-2026 will be admissible during leave and entire period of L.P.R. except during extra ordinary leave;
- (iv) The Adhoc Relief Allowance-2026 will not be treated as part of emoluments for the purpose of calculation of pension/gratuity and recovery of House Rent;
- (v) The Adhoc Relief Allowance-2026 will not be admissible to the employees during the tenure of their posting/deputation abroad;
- (vi) The Adhoc Relief Allowance-2026 will be admissible to the employees on their repatriation from posting/deputation abroad at the rate and amount which would have been admissible to them, had they not been posted abroad;
- (vii) The Adhoc Relief Allowance-2026 will be admissible during the period of suspension;
- (viii) The Adhoc Relief Allowance-2026 will not be admissible to contract employees appointed on fixed / lump sum pay package;

- (ix) The term "Basic Pay" will also include the amount of Personal Pay granted on account of annual increment(s) beyond the maximum of the existing pay scales.

9. **Special Pays & Allowances:**

Various allowances admissible to civil employees of the Government of the Punjab (calculated on the minimum of pay scales or running Basic Pay Scales) shall stand enhanced under the Revised Basic Pay Scales, 2026. However, if specific year of a Pay Scale is explicitly mentioned in the sanction, no change/modification/upward revision shall be admissible, except with the approval of the Government.

10. **Conveyance Allowance:**

Conveyance Allowance, admissible to civil servants of Punjab Government, shall be revised as per following rates:

01-04	Rs.1,785/-	Rs.2,678/-
05-10	Rs.1,932/-	Rs.2,898/-
11-15	Rs.2,856/-	Rs.4,284/-
16 & above	Rs.5,000/-	Rs.7,500/-

All other terms and conditions will remain the same.

11. **Special Conveyance Allowance:**

Special Conveyance Allowance, admissible to disabled employees of Punjab Government, shall be enhanced from Rs.6,000/- per month to Rs.10,000/- per month, in addition to normal Conveyance Allowance. All other terms and conditions will remain the same.

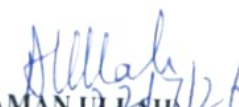
12. **Option:**

- (a) All the existing civil servants (BS-1 to 22) of the Punjab Government, shall within 30 days commencing from the date of issuance of this Notification, exercise an irrevocable option in writing and communicate it to the Accountant General Punjab / District Accounts Offices / DDO concerned, as the case may be, either to continue to draw salary in the Basic Pay Scales-2022 or in the Basic Pay Scales-2026, as specified in this notification.
- (b) An existing employee, as aforesaid, who does not exercise and communicate his/her option within the specified time limit, shall be deemed to have opted for the Scheme of Basic Pay Scales-2026.

13. All existing rules / orders on the subject shall be considered to have been modified to the extent indicated above. All the existing rules / orders not so modified shall continue to be in force under this scheme.

14. **Anomalies:**

An Anomaly Committee shall be set up in the Finance Department (Regulations Wing) to resolve the anomalies, if any, arising out in the implementation of the Basic Pay Scales – 2026.

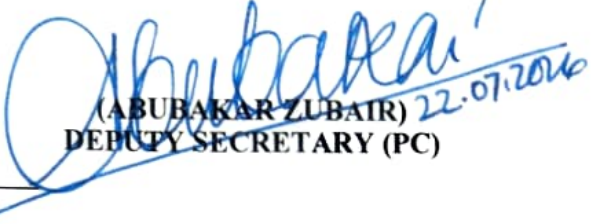
